

NOTICE OF UNCLAIMED MONEY

Notice is hereby given by the San Diego Superior Court that money, not the property of said Court, now on deposit with the Administrative Office of the Courts, State of California, which remains unclaimed in such account for over three years will become the property of the San Diego Superior Court unless a claim is filed on or before May 16, 2011.

- A copy of the court order showing disposition of funds.
- Any other supporting document(s) that authorize you to proceed on behalf of claimant.

All documents must include the claimant's name, address, amount of claim, the grounds on which the claim is founded, and any other additional information that supports the claim.
