#### E-FILING

Attorneys and self-represented litigants may file documents electronically in Family Law and Family Support Division cases. Some exceptions apply. Refer to Electronic Filing Requirements (Family) (SDSC Form #D-305) available on the court's website at www.sdcourt.ca.gov for additional information, and the current list of documents not accepted for e-filing.



## REQUEST FOR DOMESTIC VIOLENCE RESTRAINING ORDER

Pursuant to Family Code section 6307, requests for Domestic Violence Restraining Orders may be submitted electronically through one of the court's approved e-filing service providers (EFSPs), with exceptions for specific documents. Refer to Electronic Filing Requirements (Family) (SDSC Form #D-305) available on the court's website at www.sdcourt.ca.gov for additional information, and the current list of documents not accepted for e-filing.



#### **GUIDE AND FILE**

Tyler Technologies offers the "Guide and File" online service that provides user-friendly forms preparation. Required forms can be prepared online by answering a series of interview questions. To Appear In-Person:

Arrive at the courthouse at least 30 minutes before your scheduled hearing and report directly to the assigned courtroom.



- To Appear Remotely:
  - Parties can attend the hearing by video or audio conference using the free Microsoft Teams App, unless otherwise ordered by the court.
