STIPULATION FOR COURT COMMISSIONER TO ACT AS TEMPORARY JUDGE FOR ALL PURPOSES	

Commissioner _____ is a judicial officer selected by the judges of the San Diego Superior Court and assigned to hear and determine civil cases because of his or her experience, skill, and knowledge.

For a commissioner to act as a judge in a case, all parties must stipulate that he or she can act as a temporary judge. If any party does not stipulate, the case will be reassigned to a judge for all hearings. A commissioner's authority to act as a judge with the parties' consent comes from article VI, sections 21 and 22 of the California Constitution, and Code of Civil Procedure section 259(d).

To "stipulate" means that the parties consent to the appointment of Commissioner _____ as a judge for all hearings and trials in this case, including any contempt proceedings and post-judgment matters.
