# DEPARTMENT E-8 TRIAL / EVIDENTIARY HEARING/LONG RFO REQUIREMENTS

Five court days before the trial or hearing, the Court requires a trial notebook (notebook may be joint or individual) be prepared that it includes the following:

- 1. Trial Brief (San Diego Superior Court Form D-241, or a separate brief containing the same information)
- Pre-mark Exhibits (Petitioner should use numbers for their exhibits pink tags; Respondent should use letters for their exhibits – yellow tags). Try to eliminate duplicative exhibits. Exhibits should be individually marked. If an exhibit has multiple pages, Bates Stamp the individual pages. If you are submitting photographs, each photograph should have an individual exhibit number. See California Rule of Court 2.1040, San Diego Local Rules 5.5.5 (RFOs) and 5.8.3 (Trials) for submission of electronic recordings, which includes the requirement of lodging and serving a transcript of any recording.
- 3. Exhibit List Grid format see below for example
- 4. Witness List (California Judicial Council Form FL-321)

#### NOTE: 2 trial notebooks are required - One for the Court and one for the clerk.

**REPORTER:** You will need to provide your own reporter should you want the hearing reported unless there is a fee waiver in the case. We will only provide a reporter for contempt hearings. Please go to the court's website at <u>www.sdcourt.ca.gov</u> for a list of reporters.
